Pursuant to Article 60 of the Law on Public Procurements (the Official Gazette of RS, nos. 124/12, 14/15 and 68/15), JKP Gradskačistoća Belgrade (PUC City Sanitation) as the Purchaser has issued

AN INVITATION TO SUBMIT BIDS

Type of public procurement procedure: **Negotiation procedure according to Article 35 paragraph 1 item 1) of the Law on Public Procurements**, to be conducted for the purpose of a contract conclusion.

Name and address of the Purchaser: **JKP Gradskačistoća, 4, MijeKovačevića, Belgrade.**

Type of Purchaser: **Public companies – local self-government.**

The Purchaser's web page: www.gradskacistoca.rs.

Type of subject of public procurement: **Goods.**

Public procurement serial number: **P.P. 2/2019-G.**

Subject of public procurement: **Vehicles and equipment for maintenance of sanitation in public areas.**

Name and designation in general vocabulary of procurements: Motor vehicles for special purposes - 34144000-8.

Subject of this public procurement is not formed in lots.

1. Criteria for bid assessment: **"the lowest quoted price"**.

2. The tender documentation may be downloaded in electronic format from the web page of the Purchaser: www.gradskacistoca.rs, at the Portal of Public Procurements of RS: portal.ujn.gov.rs, and at the Portal of Public Procurements of the City of Belgrade: <https://nabavke.beograd.gov.rs>.

3. All interested domestic and foreign legal entities and natural persons shall have the right to participate in this public procurement procedure provided they meet compulsory and additional requirements for participation in the procedure, in accordance with Article 75 paragraph 1 items 1), 2) and 4) and paragraph 2 and Article 76 of the Law on Public Procurements (the Official Gazette of RS, nos. 124/12, 14/15 and 68/15).

Fulfilment of conditions for participation in this public procurement procedure shall be evidenced in the manner described in the tender documentation.

Note:

The bidders registered in the Register of Bidders (kept by the Agency of Business Registers, in accordance with Article 78 of the Law on Public Procurements) shall not be obliged to submit evidence of fulfilment of requirements contained in Article 75 paragraph 1 items 1), 2) and 4) of the Law on Public Procurements for the reason that the Register of Bidders is available to the public at the web page of the competent body: the Agency of Business Registers (www.apr.gov.rs), and at the web page of the Public Procurement Directorate (www.ujn.gov.rs). In case evidence shall not be attached to a bid, the bidders shall be obliged, pursuant to Article 79 paragraph 5 of the Law on Public Procurements, to mention in their bids the web page address at which the required data are available publicly.

4. Bidders shall submit their bids in a sealed envelope or a box, closed in such a manner that it may be established with certainty that it is opened for the first time during the opening of bids, either directly or by mail to the address of the Purchaser: JKP Gradskačistoća Beograd, MijeKovačevića 4, Beograd – pisarnica, marked: "Ponudazajavnunabavkubroj O.P. 9/2019-G – komisijskiotvriti".

The name and the address of the bidder are to be stated at the back of the envelope or the box.

Any bidder may only submit one bid.

A Bidder submitting an independent bid may not participate in a joint bid at the same time or as sub-contractor, and the same legal entity or natural person may not participate in several joint bids.

In case a bid shall be submitted by a group of bidders, it is necessary to indicate on the envelope that it is a bid by a group of bidders and names and addresses of all participants in a joint bid.

Within the period prescribed for the submission of bids, the bidders may amend, supplement or revoke their bids in the manner defined in the tender documentation.

Bidders may not submit their bids in versions.

5. The reason for application of negotiation procedure:

The grounds for application of negotiation procedure according to the provisions of Article 35 paragraph 1 item 1) of the Law on Public Procurements:

The Purchaser in the open procedure of public procurement number O. P. 9/2019-G: Vehicles and Equipment for Maintenance of Sanitation in Public Areas, adopted a decision to suspend the public procurement procedure (Decision number 18/44-Gof 27 June 2019) for the reason that all received bids had been assessed as unacceptable. The Purchaser has opted the most opportune manner to conduct the procurement of subject goods, according to the provisions of Article 35 paragraph 1 item 1 of the Law on Public Procurements prescribing that previously defined conditions for participation in the procedure, the technical specification and the criteria for contract award shall not be changed.

The Purchaser has opted the publication of an invitation for submission of bids in the subject public procurement procedure in order to make it possible for all interested parties to submit their bids.

6. Bids shall be deemed submitted on time if received by the Purchaser until 07. August 2019 before 09:30 a.m.

Late bids shall be those bids received by the Purchaser after the time specified for submission of bids.

Upon the completion of bid opening procedure, the Purchaser's Commission for Public Procurements shall return unopened bids to Bidders marking them as late.

7. Bid opening procedure shall be public, after the expiry of time for submission of bids, on 07. August 2019 at 10:00 a.m., at the Purchaser's address in the conference room.

Bid opening procedure shall be public and may be attended by any interested person.

Authorised representatives of the Bidder may only take part in bid opening procedure.

A representative of the Bidder shall be obliged to provide a properly certified authorisation for participation in bid opening procedure.

8. The Purchaser shall be obliged to adopt a decision concerning this public procurement within 25 days from the date of public bid opening procedure.
